

Inter-Community Hockey League

Constitution

1. Name and Affiliation

- 1.1. This Organization shall be known as the Inter-Community Hockey League hereinafter to be referred to as the ICHL.
- 1.2. The ICHL by virtue of its affiliation with Ontario Minor Hockey Association (OMHA) that is governed by the Ontario Hockey Federation (OHF) and Hockey Canada (HC) shall have jurisdiction to govern and administer minor hockey over the member teams within the ICHL.

2. Objectives

- 2.1. To promote hockey as a sport played for enjoyment, while supporting skill development, sportsmanship, and respect for all officials, opponents and spectators. The principles that will guide the conduct of players, coaches and spectators are:
 - Promote safe play and self control
 - Respect the rules
 - Respect the opponents
 - Respect officials and their decisions
- 2.2. To provide fun, recreation, development and competition for all who desire to participate in hockey, given due consideration to individual capabilities.

3. Membership

- 3.1. Association membership in the ICHL shall be governed by the ICHL Committee through collaboration of its members:

- 3.2. Membership may be extended to other associations or other interested parties as approved by the ICHL Committee and must be in good standing with the OMHA.
- 3.3. All parents or guardians of children playing in the ICHL in the current year.
- 3.4. Coaches, managers and team officials of the ICHL in the current year.
- 3.5. Referees in Chiefs (or their designates) of member associations involved in the current playing year.

4. Committee

- 4.1. The business and affairs of the ICHL shall be conducted by the Committee and the League Convener who shall act in accordance with this constitution and such by-laws and regulations as may from time to time be enacted by the ICHL.
- 4.2. The members of the Committee of the ICHL shall consist of:
 - Not more than two Committee Members from each active member association. These members are appointed by the member's association.
 - Each Association will receive one vote, regardless of the number of Committee members per association.

5. General Meetings

- 5.1. Shall be called and chaired by the League Convenor. Meetings shall be held at least once a month during the hockey season (September – May).
- 5.2. Quorum shall consist of a simple majority of the executive.
- 5.3. Each meeting of the league shall be governed by Parliamentary procedures related to all motions, votes, discussions, and procedures.
- 5.4. In the event of a tie vote the League Convener may vote to break the tie.

6. Special Meetings

- 6.1. At the request of shall be communicated to the League Convener, who will arrange the meeting within 14 days of the request.
